HOMESTEAD	Property which is set aside for the benefit of specific family members and which cannot be transferred by the decedent to a third party
INQUISITION	An investigation made by a sheriff and a jury impaneled by him.
INSTRUMENT	Any formal Document.
INTER VIVOS TRUST	Living trust
INTESTATE	A person who dies without a will.
ISSUE	All lineal descendants.
ITEM	A paragraph in a will.
JOINT TENANCY	Property held in the names of two or more persons. The property passes to the surviving joint tenant on death of the other joint tenant
LATE	Defunct or dead.
LEGACY	A gift by will.
LETTERS OF ADMINISTRATION	Document issued by the Register of Wills authorizing the administrator of an intestate estate to function in that assignment.
LETTERS OF TESTAMENTARY	The formal authorization for the executor of a will to function in that capacity.
LICENSE	A permission granted by competent authority to engage in a business or occupation or in an activity otherwise unlawful
LIVING TRUST	A trust that becomes effective during the lifetime of the settlor (aka intervivos trust)
MESSUAGE	A dwelling house.
MOIETY	The half of anything. Joint tenants are said to hold by moieties.
NEXT FRIEND	A person who volunteers to bring an action for someone incapable of suing in his/her own name.
NUNCUPATIVE WILL	An oral will declared or dictated by a testator in his last sickness, heard by a prescribed number of witnesses and reduced to written form within a limited time.
PER STRIPES	To distribute a share to a descendant of a deceased beneficiary
PIENARY	Complete in every respect, absolute, unqualified
PROBATE	Originally, relating to the proof of wills. In American law, now a general term used to include all matters of which probate courts have jurisdiction.
PROGENY	Descendants of a common ancestor.
RENUNCIATION	The act by which a person abandons the right of administration or the appointment as executor.
SEIZED	An owner's possession of a freehold property.
SETTLOR	One that makes a settlement or creates a trust of property
TESTAMENT	An act by which a person determines the disposition of his or her property after death
TESTATE	To die leaving a valid will.
TESTATOR/TESTATRIX	One who dies leaving a will.
TRUST	A property interest held by one person for the benefit of another
VENDUE	A sale made under authority of law, as by an administrator or executor.
YEOMAN	A common man.
